IMPORTANT NOTES:

- 1. Applications requiring referral or return will incur additional processing / postage fees.
- Once submitted, an application cannot be cancelled. Unresolved issues lasting beyond 6 months will result in the application being voided and any fees paid will be forfeited.
- If it transpires an equine was registered previously, no refund will issue. If an issued passport must later be cancelled, cancellation fees become payable by the applicant.
- Risk of loss and the cost of duplicate passports will be entirely borne by the applicant when sent by standard post.
- Date of Birth (DD/MM/YYYY) must be confirmed by the identifying vet on the markings, if only the year of birth is detailed, Jan 1st of that year will be the recorded.
